Georgia Law requires that an applicant for a salesperson's license must: (1) complete a course or courses totaling a minimum of 75 credit hours covering the state mandated curriculum, (2) pass the pre-license exam given by the school with a minimum score of 75%, (3) pass a state examination with a score of 75% or better, (4) be at least 18 years of age, (5) be a high school graduate or the holder of a GED and (6) submit a GCIC (Georgia Crime Information Center) report. Our School's Pre-License program has been approved by the Georgia Real Estate Commission as satisfying the mandated curriculum. Barney Fletcher Schools offers day and evening classes for the required 75-hour course. A computer based course is also available in which all work is completed on a home or work computer. Upon completion of the course and passing a proctored school exam, the student has satisfied the educational requirement for taking the state examination.

Registrations

Rescheduling
